Tunbridge Select Board

It is with no small amount of frustration tempered by optimism that we offer an update on the state of the transfer station. As previously reported, in the spring of 2015 the board made the decision to return the town's business to Casella Waste Systems. As part of this transition the town is renting a recycling compactor to test. Unfortunately, we experienced a number of problems with the installation, including instances in which the problems appeared to be fixed only to reappear at later date. We are confident that the compactor and the contract with Casella will provide a higher quality of service over time. We would again like to apologize for the inconvenience that many experienced during this time.

With Special Town Meeting behind us, the board turned its attention back to other business, which in short order became the preparation of annual budgets and the board's submission to the town report. Much as we did last year, the board did its best to take into account the current economic climate, expectations for future economic developments, changes in the costs of materials, and other factors in attempting to be realistic, not aspirational, in it is budgets. The town report will contain greater detail about changes to each significant budget category. We encourage residents to review these budgets - and the narrative - carefully and be prepared to suggest alterations from the floor. These budgets are ultimately the voters', and we look forward to discussing them with you at Town Meeting.

We continued our new-to-this-year set calendar of meeting with town committees at regular intervals. This has allowed our new administrative assistant, Cynthia Masterman, to get to know many of you personally. As the same person had filled the roles of town clerk and administrative assistant for a number of years, the board and Cynthia have been learning together exactly how comprehensive the role of the administrative assistant is. We feel that we are developing a good working relationship and are happy to have Cynthia on working with us.

It is with great regret that I, Erin, notify you that I resigned from the positions of selectperson and Cemetery Commissioner at the end of January. I am no longer living fulltime in town, and I feel strongly that the town deserves a board compromised of residents, not interested parties. It was important to me that my resignation was filed so that voters could select my replacement at town meeting; this seems like the most democratic way to affect a transition. I am happy to discuss the role with anyone who thinks s/he might be interested in running for the board.

As always, selectboard meetings are open to the public. Our standing meeting schedule is now every Monday at 6:00pm in the town offices. We are trying to hold every other Monday for working meetings, so please contact Cynthia (889-5510) if you would like to be on the agenda. WANTED: Act 46 Advisory Committee Members

It is a busy time of year, but much more so this year as you have probably guessed from the papers. Because you can read our report on this past year in the Town Report and can hear about the details of this year's school budget in our budget mailer, we would like to focus on one particular issue here -- Act 46 compliance.

First, thank you to all who came to our first Act 46 forum in December. It was very helpful to hear from so many Tunbridge residents in person. It was a great turnout! Thank you, too, to all of you who filled out the voter survey. We have had close to a 40% response rate so far -- phenomenal! It's still not too late to turn in your survey if it is sitting in a pile at home. It already has a stamp on it, so just take a few minutes to fill it out and throw it in the mailbox! We will go over the results of that survey at our next Act 46 forum, Sunday, February 21, at 3 pm. Please come!

Now the most important thing: the school board is forming an advisory committee that will focus exclusively on Act 46 options available to Tunbridge. So far, we as a school board have been part of discussions at the Supervisory Union (SU) level examining merger proposals that would satisfy Act 46 requirements, and they have been very productive. Another option that emerged at the last forum was applying to the Agency of Education and State Board of Education to remain a stand-alone district. Additionally, the neighboring towns of Strafford, Sharon, and Thetford have formed a formal study group to pursue a merger option outside of our SU. And Waits River, the union district for the towns of Corinth and Topsham, hosted a regional meeting of similar districts, including Tunbridge, from several different SUs in our part of the state. This is a lot of information to evaluate while also doing not only the usual business of a school board, but also continuing our work of merging with a neighboring SU per order of the State Board of Education. This is why we need YOU!

We are seeking applications to serve on the advisory committee. We hope to have the broadest range of perspectives that we can. It will be a nine-person committee made up as follows: five adult residents, one school board member, two students who reside in Tunbridge, and one teacher (ideally -- it will depend on the response we get). The work of the committee would be to analyze and evaluate the different options available to Tunbridge, drawing on information gathered through the voter survey and public forums, and then

come to the school board with a formal recommendation on what would best serve the interests and values of the Town of Tunbridge. This recommendation will inform what proposal we will ultimately pursue with the state. And it may take several tries, both with the state and with the voters! We must be clear on two points, however: first, that the committee is advisory, and the board may ultimately put a different proposal before the voters for approval, especially if we receive feedback from the state that a proposal is not likely to be approved at the state level; and second, that in fact it will ultimately be for the voters to approve any proposal, merger or otherwise, so everyone will have their say at the ballot box.

If this work interests you (and we hope that it does!), please mail or email a short personal statement to the Board. It would be helpful to note any relevant experience you may bring to the task, such as an accounting or financial background, a background in education, experience analyzing populations, or experience as a parent/grandparent of a Tunbridge child and/or an alumn of the Tunbridge school system. We plan to appoint the committee either before or shortly after Town Meeting day. Count on your work beginning in early March. Depending on the course Tunbridge takes under Act 46, your work could end as early as December of this year or as late as the first half of 2018. (Sorry, we didn't mean to scare you!)

In sum, please join our Act 46 Advisory Committee. Please also attend our next Act 46 forum, Sunday, February 21, at 3 pm. Thank you so much for your interest in the work of education!

Tunbridge is a founding member of ECFiber, a consortium of 24 municipalities in East-Central Vermont working to bring community-owned, high-speed Internet to every home, business, and civic institution in its territory. Its top priority is reaching as many unserved locations as possible, with a focus on back roads and outlying neighborhoods. At inception the organization opted to build a Fiber-to-the-Home (FTTH) network that has the ability to provide the highest possible bandwidth, without distance or other limitations, to all customer locations within its territory.

During FY 2015, ECFiber succeeded in achieving its goal of reaching 1200 active subscribers. It has added network in Tunbridge, Chelsea, Randolph and Norwich. In Tunbridge there has been service up RT 110 from SoRo to Button and then up Button to Potash and from there to Kibbling and through to Strafford. Also new lines have been added: 1)from Whitney Hill in North Tunbridge through to Dickerman and down Chelsea Line Rd. 2) several from the Randolph side in the area of Gage RD and Gifford with a third section under construction on the back side of the Spring Road. ECFiber has successfully lobbied the state legislature to pass legislation that allows for the creation of telecommunication utility districts. With the enabling law in effect, the East Central Vermont Telecommunications District (ECVTD) became the new governing body for ECFiber, with all of the 24 member towns of the former Inter-Local Contract (ILC) voting to join the ECVTD. This change removes a barrier to obtaining large investments by replacing the unfamiliar ILC structure with a more familiar Utility District structure. With the potential for greater investment in ECFiber there should be a much more rapid completion of the ECFiber network, including the possibility of all roads in Tubridge -- hopefully more to be announced on that subject soon. The Listers have seen some changes in our typical work flow this year as legislative changes extended the deadlines for filing late homesteads and changes in the Current Use program provided a one-time only option for landowners to withdraw land enrolled in that program ("Current Use 2015 Easy-Outs"). All of these changes have now been accounted and the grand list has been finalized for 2015.

We were sorry to lose our newest Lister, Betsy Sponable, but she only went as far as the other side of the hall, to fill the position left vacant when Wendy McCullough stepped down as our long-time Town Clerk (and everything else she covered!). We wish Betsy well in her new role in that position, welcome new selectboard Administrative Assistant Cynthia Masterman, and send best wishes to Wendy in her next adventures. These changes mean that we will elect a new Lister for a 3-year position at Town Meeting on March 1, 2016.

April 1st is our deadline for changes to property assessments to be accounted with this year's Grand List; real estate sales and changes to property after that date will not affect the Grand List until 2017. Although we may visit after April 1st, our aim is to assess the status of any changes as of that date. We thus continue our rotations in the southeast corner of town (we try to focus on one guarter of the town each year, plus any major changes that we are aware of - we do not have a permit system). The annual state wide sales study arrived in December, and our Common Level of Appraisal (CLA) shows our current assessed values at 114.93% of statistically-derived "fair market value". This indicates that valid sales in Tunbridge (those with no special considerations such as family relations or lack of market exposure) are running roughly 15% below the current assessed values that were largely developed through our last town-wide reappraisal in 2010. The sales market has unevenly sagged since then as we have seen a rise in our CLA each year since 2010 (101.79%, 102.75%, 106.04%, 111.95%, 114.93%). We are legally mandated to assess property at "fair market value".

We are also strongly committed (and legally mandated) to keep property values fair and equitable across the town. The Coefficient of Dispersion (COD) gives a measure of equity across the town, and a COD of less than 10% is considered to indicate a high level of equity. The 2015 Sales Study shows our COD at 13.03% (last 5 years: 5.46%, 6.93%, 9.71%, 10.03%, 13.03%).

Please understand that when we consider grievances and appeals we are trying to maintain as accurate an assessment of fair market value as possible as well as maintain equity, and the assessments we are considering have the 2010 town-wide reappraisal as the most recent baseline. The CLA is a useful measure for helping calibrate current assessments in that light (divide the current assessed value by the CLA to get an idea of current fair market value in equitable relation to that 2010 town-wide baseline).

With everyone in town assessed on the same basis (values developed in the town-wide reappraisal in 2010), the Grand List is then used as the basis onwhich everyone contributes their fair share of taxes. Taxes are raised as necessary to cover the expenditures we vote on at Town Meeting. State statutes require a town-wide reappraisal for a CLA <80% or a COD>20%; we have no statutory requirements for conducting such a reappraisal at this time.

By the time this TQ is read, The Tunbridge Church will have held its Feb. 7 Annual Meeting and hosted a new community event on Feb. 13 — Just Desserts, an evening of music, desserts and silent auction to raise funds to paint the Tunbridge Village church.

After three months with Sunday guest ministers, the church will have an Interim Pastor to lead services and perform other pastoral duties. The final phase of finding a permanent pastor will then begin. A Pastor Search Committee will lead the effort, which will include discussions within the church and community about the church and its services.

Thirty-two people were guests at a Parish House lunch for seniors who went home with Halloween treat bags filled by the Youth Group. This was the final 2015 Super Senior Luncheon sponsored by the Outreach Committee's Community Connections program. At Thanksgiving, 52 seniors received bags filled with baked goods, cheese, fruit and other treats.

In October the church hosted what will be an annual event — Anything Apple, an afternoon of foods, apple pressing, silent auction, pie contest, and vendors on the lawn. Proceeds went to the church painting fund. Everyone's support and patronage for these programs is greatly appreciated.
