Meeting called to order at 6:10pm

Road Foreman Update

- The ton truck came back from the shop with a cheaper bill than expected.
- Truck no. 2 just had a front spring replaced at McLeod's.
- The grader will need a new set of chains sometime soon. Hoyt suspects it will cost around \$2,000 for four.
- Hoyt is considering getting hard pack for the roads from a vendor in Randolph, instead of the vendor currently used in Chelsea.

Update from Town Hall Manager

Judy Howe, Manager of the Town Hall, came to ask the Selectboard if she could discount the rental rate of the Town Hall while the kitchen is under construction, due to the messiness of the project. The Board unanimously agreed.

Howe also asked if Mike Howe, could repair the key pad at the Town Hall after construction has finished, because the current one is broken.

McPhetres made a motion to hire Mike Howe to install an electronic key pad at the Town Hall for \$175.00. O'Brien seconded. So moved.

Howe also asked if the Board would approve Mike Howe installing a doorbell on the back door of the Town Office, so that if a person was at the locked back door and no one was within earshot to hear a knock, the Town Clerk could hear a doorbell ring from her office.

McPhetres made a motion to hire Mike Howe to install a doorbell on the back door of the Town Office for \$176.00. O'Brien seconded. So moved.

Other Business

O'Brien made a motion to have the Town pay for dinner for 150 people, at \$5.00 per person, at the 4 Town Meeting to be hosted in Tunbridge on 3/14/19. McPhetres seconded. So moved.

O'Brien left the meeting at this point to attend the South Royalton Pre-Town Meeting.


