

**TOWN OF TUNBRIDGE  
SELECTBOARD MEETING**

Meeting called to order 6:05pm.

**Update from Road Foreman**

Hoyt began by letting the Board know that Blaktop won't be available to do a small paving job on Strafford Rd. until Spring. He's received quotes from Blaktop and Freshcoat.

The ditching project on Monarch Hill Rd. will be finished after a couple more days of work.

Sand for the winter is being stockpiled at the Garage. Half of stone order has been stockpiled as well.

Repairs on the Flint Bridge will begin soon. The insurance approval and reimbursement has come through.

There is a culvert on Dickerman Hill that needs to be replaced this fall.

Conner asked the Board and Hoyt if there was any improvements they could suggest for the Tunbridge Transfer Station, as a grant offered by the Central Vermont Solid Waste Management District could provide up to \$5,000 to assist solid waste efforts. A cement pad underneath the junk container, fence repair and fixing up the shack to be a "swap shack" were all floated. Conner will investigate the grant further.

**Other Business**

Conner reminded the Board of the vacancy in the First Constable position in town. She brought it up because Kevin Barnaby, the Second Constable, has been overwhelmed with complaints in the past couple weeks and could use help. The Board agreed to each think of a potential candidate to present at the next meeting.

Barnaby has received three complaints from townspeople in about the past two weeks. Conner received a phone call from a resident who was bitten by a dog on Button Hill Road last week.

Conner also informed the Board that she has sent out challenge letters to those identified as potential non-residents at the 9/9 Board of Civil Authority meeting. 88 letters were sent, and she has received some responses.

The Board is planning to begin reviewing the budget in preparation for next year's.

Orders and warrants signed. Minutes signed.

McPhetres motioned to adjourn at 8:03pm. O'Brien seconded. So moved.
