Other Business

Simon Bradford and Shawn Young want to discuss the purchase of a new fire truck. Years ago when a new truck was purchased, a loan was gotten by the town to finance the truck. Young has been in contact with a financing company that the Fire Department can use on their own without the town. The interest rate would be 6.75%. The payment amount would be \$45,000 for 10 years. The town could take a loan out with the Fire Department for a lesser municipal rate of 6.5%. The first payment is \$118,927 when the chassis comes to the shop and then the remainder of the payment is due when the truck is delivered.

They are needing to lock in the price before the end of the year. There is 425-500 days until the truck is delivered. Chief Bradford is looking for the Selectboard's blessing to sing the paperwork. McPhetres makes a motion to allow the Fire Department to purchase a Fire Truck for \$655,631 and to have Treasurer Hoyt make the first payment of \$119,000 when the chassis comes in. O'Brien seconds. All aye. So moved.
