# **Road Report- Rodney Hoyt**

Sheriff Palmer states that he is interested in regional policing and is really pushing for this. His hourly rate is set at \$65.00. Dave Kimball asks how dispatching works; will they contact Windsor or will they just call the state police? It used to be that it was up to the discretion of the dispatcher if they called the sheriffs. Windsor Sheriff's Department is dispatched through Woodstock, but is working on stream lining the process to make sure the calls get sent to him. Would be open to a four town policing with Vershire and Strafford as well. Robert Childs is still encouraging the four town policing.

### **Delinquent Tax Collector Joe Paquin Tax Sale Approval**
